### AUGUST MEETING

Speaker for the August 5 meeting will be Roger Freeman.

**An Executive Hutchison would be a disaster for women's rights and health.**

## The Case For A Surtax

The House Ways and Means Committee has proposed [implementing a tax surcharge](#) on the **richest one percent of Americans**, with the revenue going toward financing a portion of the estimated [\\$1 trillion cost](#) for health care reform. Under [the House proposal](#), the surtax would begin in 2011 and constitute a one percent marginal rate for households making between \$350,000 and \$500,000, 1.5 percent for households making \$500,000 to \$1 million, and 5.4 percent for those making more than \$1 million.

As House Speaker Nancy Pelosi (D-CA) put it, "Let's leapfrog over the middle class to the [wealthiest people in our country](#). They've had it pretty good the last eight years in terms of tax policy under President Bush. And we think that's a place you can go."

Yesterday, Secretary of Health and Human Services Kathleen Sebelius called the tax "[a legitimate way to go forward](#)." And as Families USA executive director Ron Pollack said, "Since this group enjoyed a significant tax reduction windfall during the last decade -- and since this windfall played a big role in burgeoning federal deficits -- it makes sense that this group bear some burden as part of the [effort to secure America's long-term economic future](#) through health-care reform."

The surcharge would raise \$544 billion from those same households over 10 years. The surcharge "would require the richest one percent to give back some, [but not all](#), of the tax cuts they received over the 2001-2010 period."

**"It certainly is okay for me to tell my friends on Wall Street, who just got a bonus of \$600,000, that they're going to pay more in taxes so that we can [lower health care costs in America](#)," Sen. Bernie Sanders (I-VT) said.**

**According to estimates from Citizens for Tax Justice (CTJ) 98.7 percent of Americans will be totally unaffected by the surcharge.**

**Pay of Top Earners Erodes Social Security Fund Expected to Be Exhausted in 2037

The nation's wealth gap is widening amid an uproar about lofty pay packages in the financial world.

**Executives and other highly compensated employees now receive more than one-third of all pay in the U.S., according to a Wall Street Journal analysis of Social Security Administration data -- without counting billions of dollars more in pay that remains off federal radar screens that measure wages and salaries. **Highly paid employees received nearly \$2.1 trillion of the \$6.4 trillion in total U.S. pay in 2007**, the latest figures available. The compensation numbers don't include incentive stock options, unexercised stock options, unvested restricted stock units and certain benefits....**

## A War Against Organizing

A Rite Aid distribution center employee recently described what happened when workers tried to form a union in their California workplace.. .(which was)

surveillance, constant threats and harassment; they were repeatedly interrogated, one on one, about how they planned to vote; 2 co-workers fired; and the rest lived in fear that they, too, might get a pink slip.

The union filed numerous charges of unfair labor practices and eventually won the organizing election. But 3 years after the campaign began, she and her fellow Rite Aid workers still don't have a contract.

Rite Aid takes full advantage of current labor law to keep workers from exercising their full rights to organize and collectively bargain under the National Labor Relations Act. **Such behavior by U.S. companies during union organizing campaigns has become routine**, and our nation's labor laws neither protect workers' rights nor provide disincentives for employers to stop disregarding those rights.

There has been a steady decline of workers' rights in the past several decades. The failure of the system to defend workers' rights in a timely manner multiplies the obstacles workers face when seeking union representation, creating delays that favor employers. Employers appeal a high percentage of the cases to the National Labor Relations Board (NLRB), and **in the most egregious instances, the employer can count on a final decision being held up by three to five years.**

**Fifty-two percent** of workers who form a union are still without a contract a year after they win an election and **37 percent** remain without a contract two years after the election. For employers, labor law provides yet another means to indefinitely delay unionization...
