### Business Cards

Kurt Peppard and Tim Burns are working on getting business cards for the officers and PCOs of the 30<sup>th</sup> District Democrats. The print shop we are dealing with is Urban Press, a Union Shop located in Georgetown and owned and operated by women. Kurt has worked with them for about 25 years and vouches for their quality.

The cards are printed on 100% recycled paper and have a "Union Bug" as well as our new logo and 30<sup>th</sup> LD information and your personal information (name, office, address/phone/email). Prices range from \$12.81 for 100 cards to \$31.12 for 500 cards depending on the total number of cards we order at one time. The minimum run is 1600 total cards.

The Senate just voted to allow debate on the Health Care Bill by a 60 to 39 margin (all Democrats and Independents voting for and 39 Republicans voting against. ) Sen. George Voinovich,(R-Ohio) abstained.

**As we draw to the close** of an astounding year it's time to take inventory of what has been accomplished and what has been left to do.

In fairness to our new president, Barack Obama, we must remember that he was presented with an enormous mess from the previous administration and a huge catalogue of things to get done in short order. Depending upon your view point and your priorities, rating President Obama is a mixed bag.

Economically, a lot of people are pretty unhappy with Obama's record. Everything seems to have gone the way of Wall Street and Main Street, our street, seems to have been left out of the recovery. But, he did get the Lily Ledbetter bill passed, unemployment benefits have been extended and some stimulus money seems to have found its way to Main Street.

A number of us are pretty upset with his administration's slowness in reforming the Justice Department and in replacing our nation's U.S. Attorneys, a task which is usually easily accomplished in the first year. We are plagued with uncertain Democratic Senators from Louisiana, Nebraska, and Arkansas who find it difficult to maintain loyalty to their party, as well as a turncoat, Joe Lieberman of Connecticut – and judges have not been confirmed because of the threat of filibuster.

As the New York Times noted on Nov. 17 "Appointing federal judges, who have enormous power and serve for life, is one of the most important presidential responsibilities. President Bush, who was intent on leaving an ideological imprint on the judiciary, made his nominations quickly and pushed hard to have them confirmed. By the end of his first year, according to a report by the liberal group Alliance for Justice, he had nominated 65 federal judges and 28 were confirmed.

"By that measure ... Mr. Obama has moved slowly. As of Nov. 4, he had nominated just 26 appellate and district court judges, and only four of them had been confirmed.... Obama nominees who have been reported out of the Judiciary Committee have waited months for a vote from the full Senate, far longer than is necessary.

"Senate Republicans have been doing their best to drag things out. In March, every Republican senator signed an outrageous letter to the White House warning that they (Continued in column to the right >>>>>)

One of the major factors is an extremely right wing bloc of Republicans serving on the Senate Judiciary Committee who have worked overtime to block confirmation of Obama's judicial nominations. Ranking member of the Committee is Jefferson Beauregard Sessions III, the junior senator from Alabama who is to be remembered for his crude harassment of Sonia Sotomayor during her confirmation hearings. Also on the committee are Orrin Hatch of Utah, Chuck Grassley of Iowa, Jon Kyl of Arizona, Lindsey Graham of South Carolina, John Cornyn of Texas, and lastly, Tom Coburn of Oklahoma who loves to secretly put holds on Senate actions.

A historic moment was achieved when all Senators on the Democratic side united to allow the actual healthcare reform legislation to come to the floor for debate. It was not the bill that most of us desired but given the general resistance by the health insurance and pharmaceutical industries and their lackeys to health care reform in this country, Harry Reid worked very hard to achieve even this much and we have to be happy with the results.

Iraq and Afghanistan and Guantanamo are still unfinished business but Obama and his people have been working hard to move forward on these issues.

It is obvious that a lot of work must also be done on campaign finance reform, media reform (almost all American media is right wing and monopolistic), additional regulation of the financial sector, as well as ongoing tweaking of health care reform legislation so – roll up your sleeves, folks, we've got a lot of work ahead of us.

. [FCC Votes to Create Net Neutrality Rules](#)

The FCC voted unanimously to begin the process of crafting formal rules for **Net Neutrality, the principle that all content on the Internet should be equally accessible to all users, and that companies cannot discriminate or block some content in favor of another content.**

While the FCC considers the first steps toward ensuring Net Neutrality, the telecom firms that would be affected by the rules and their trade groups have been *inundating Congress with campaign contributions* from the companies and their registered lobbyists. **The top recipient of their largess -- Sen. John McCain (R-Ariz.), who just introduced anti-Net Neutrality legislation** to stop the agency in its tracks.

Meanwhile, the FCC approved a measure to begin the process of formalizing a set of Net Neutrality rules that would ban ISPs from throttling content.
