2010 Legislative Session

The [2010 Washington State Legislature](#) Regular Session convened January 11, 2010. This session lasts just 60 days and will close March 11. The main focus is dealing with a projected additional \$2.6 billion shortfall for the remainder of this 2 year budget cycle.

Also, contact your representatives by calling the Toll-Free Legislative Hotline in Olympia (1.800.652.6000) and letting them know what is important to you!

[There are three parts to the 2010 Caucus and Convention Cycle.](#)

- The first part consists of the Legislative District Caucuses where delegates and alternates will be elected to go to the State Convention. Statewide, 1,200 delegates and 600 alternates will be elected. (The 30th LD will have 20 delegates and 10 alternates.)
- The second part is the County Convention where platforms are drafted and resolutions addressed. Sometimes, but not always, Legislative Districts also develop a platform and address resolutions.
- The third part is the State Convention. The delegates and alternates elected at the Legislative District Caucuses will meet to craft a State Party platform, address resolutions and vote on other important issues before the party.

Utah State Sen. Mark Madsen (R) is introducing legislation to make a holiday honoring John Moses Browning - the Utah native and "gun pioneer" who founded the Browning Arms company - on the same day as Martin Luther King Day. Madsen says, "I see them as complimentary." Madsen said he plans to meet with the NAACP to discuss his proposal. "We'll see if they can take it in the spirit it's intended," Madsen said. Salt Lake NAACP President Jeanetta Williams said she was "furious" about this. How could anyone suggest that MLK day be shared with celebrating guns since Martin Luther King was assassinated? THE BENNETT LETTER Eighteen Democratic senators have signed onto a letter urging Senate Majority Leader Harry Reid (D-NV) to pass the public option through reconciliation. HHS Secretary Kathleen Sebelius said, if the Senate decides to bring the matter up for a vote, the administration would support the effort. This as a new government report on our "broken health care system" shows how "insurance companies prosper" as "Americans suffer." Profits for the 10 largest insurance companies "increased 250 percent between 2000 and 2009, ten times faster than inflation," and "the CEOs of America's five largest insurers were each paid up to \$24 million in 2008." Let's use Medicare, which nearly every American understands. Just create "Medicare Part E" where the "E" represents "everybody." Just let any citizen in the US buy into Medicare. Simple and right on. In the stunning Jan. 21 Citizens United ruling, the U.S. Supreme Court decided that corporations should be able to spend as much as they want to support or oppose candidates in national elections. This decision was made possible by the appointments of Chief Justice John Roberts and Justice Samuel Alito, who advertised themselves during confirmation hearings as judicial conservatives. The definition of a conservative is one who wants most things to stay the same. The judicial expression of conservative decision-making is stare decisis, a fundamental tenant of constitutional law that cautions against overturning longstanding law. Citizens United is instead a glaring example of judicial activism.

Justice John Paul Stevens, in a stinging dissent, said, "The court's ruling threatens to undermine the integrity of elected institutions across the nation." Stevens further said, "The court operates with a sledgehammer rather than a scalpel when it strikes down one of Congress's most significant efforts to regulate the role that corporations and unions play in electoral politics . . . Congress crafted [current campaign law] in response to a virtual mountain of research on the corruption that previous legislation had failed to avert. The court now negates Congress's efforts without a shred of evidence."

Common Cause Mississippi and many other citizens' groups believe the path from here is clear: Congress must free itself from Wall Street's grip so that Main Street can finally get a fair shake. Congress is now considering proposals to change the way we pay for elections by blending small donor fund raising with **public funding** to reduce the pressure of fund raising from big contributors.
