Decline to Sign!

Tim Eyman and out-of-state interests are at it again, with paid signature gatherers out working to place these initiatives on this November's ballot. Both initiatives threaten Washington's environment, quality of life, and economic future.

We have an opportunity **now** to stop them.

What can you do to stop these initiatives?

Decline to sign I-1107 and I-1053.

Initiative 1107

I-1107 would cost our state hundreds of millions in lost revenue over the next two years, and would lead to further deep budget cuts. This initiative would slash the critical state income coming from taxes on soda pop, candy, gum, and bottled water. Without this already-approved funding, environmental protections will, once again, be in danger.

Initiative 1053. This initiative recycles the failed concept behind Tim Eyman's previous Initiative 960. If approved, I-1053 would force a two-thirds vote of the legislature to pass any increase in revenue for our state. As a result, the only way to balance our state's potential \$3 billion budget deficit will be through more brutal, ruthless cuts. Do you want to fight all over again for the money to fund our basic, state-provided protections that keep our **air safe, water pure, and toxic contaminations cleaned up?**

Say NO to I-1107 and I-1053. Report back ASAP when you encounter signature gatherers for 1107 and 1053. Please call or email 1-888-207-7307 or wa.declinetosign@gmail.com and let Decline to Sign organizers know where signature gatherers are in your area. This is very important. Timely information about where they are collecting signatures is critical to the success of a Decline to Sign effort to stop the initiatives from making the ballot.

More on the BP Oil Gusher (from Karen Backman)

Eleven workers lost their lives in the Deepwater Horizon rig explosion. Countless more have lost their livelihoods. The environmental devastation to marine life and coastal wetlands is unfathomable.

Yet under current law if a jury finds BP criminally negligent, the company would not necessarily have to pay any restitution to the victims of the spill -- not even to the families of rig-workers who perished or to the fishermen put out of work.

Furthermore, criminal penalties are currently too lenient to adequately deter corporate wrongdoers from authorizing risky schemes that damage the environment.

That's why I just emailed my members of Congress, urging them to support Sen. Patrick Leahy's Environmental Crimes Enforcement Act (ECEA) to make restitution for violations of the Clean Water Act mandatory and increase criminal sentences for violators.

Please join me and send an e-mail to your members of Congress, too, to treat acts like BP's catastrophic spill as serious crimes against our communities, our economy, and our environment:

2010 Elections From NARAL

PubliCola asks anti-choice, anti-birth control **Senate candidate Dino Rossi** how he would have voted on reproductive health and rights measures that have come before the Senate; his responses show that he would be a [consistent vote in opposition to women's health](#).

Horsesass blogger Goldy comments on [Dino Rossi's opposition](#) to women's rights and health. Noting that Dino Rossi tried to [avoid talking about his position on a woman's right to choose](#) during his two campaigns for governor, Goldy posts an ad from the 2008 gubernatorial race funded by Evergreen Progress that cites his opposition not only to abortion access but even to contraception.

American Crossroads, a conservative political group, is [targeting](#) Washington's Senate race.

The National Republican Congressional Committee identifies [anti-choice Rep. Dave Reichert](#) (WA-08) as one of nine vulnerable Senate Republicans.

Politico reports that [conservative women's groups](#), like the anti-choice Susan B. Anthony List, are raising money and plan to be very active in the 2010 elections.

Washington, DC-based American Beverage Association has put in [more than \\$1 million](#) for the signature gathering effort to get I-1107, which would repeal the taxes on candy, soft drinks, bottled water and certain processed foods that the legislature passed last session to help close the budget deficit.

Opponents of I-1107 point out that the anti-tax campaign is [deceiving voters](#) by referring to the tax on soda and candy as a "food tax."

The Governor's budget office released a forecast showing that state lawmakers will face a [\\$3 billion budget deficit](#) when they return to Olympia in January to write the next two-year budget. The budget forecast also shows the state will take in \$200 million less than anticipated through June 2011.
